


Dear Ms. Gavin:

On May 8, 2007, I filed a lobbying disclosure registration form on behalf of King & Spalding for InterDigital Communications Corporation (Senate ID# 21632-1002054). This filing was made in error. In fact, InterDigital Communications is not a client of King & Spalding. Consequently, we have never undertaken any lobbying activity for the company. While it would have been preferable, we understand it is not possible to withdraw this erroneous registration.
