In addition, I am also enclosing Year End reports at this time since I have been unable to complete the Senate filings electronically.

As I am sure you have noted, there are still real challenges with both the Senate and House regarding electronic filings. In particular, the link to download the form (from the Clerk of the House website) comes up only some of the time (we have troubleshot this problem with the Clerk's office and have had minor successes but they are not at all consistent successes). Although we were able to successfully file one or two reports via the House website, the form/pdf does not respond correctly when one is trying to file with the Senate (we have also troubleshot this with the Senate's Office of Public Records but this still does not respond correctly). Frankly, we have spent hours trying to file reports that should only take seconds to complete.

Hopefully, the "glitches" we (and I am sure hundreds) have experienced will be resolved soon.
