

The Honorable Nancy Erickson:

After receiving a notice of non-receipt from the Office of the Clerk, U.S. House of Representatives, regarding the absence of a lobbying disclosure report or termination report for Tricon Global Restaurants, we discovered that an error occurred in the filing of our report for midyear 2000. Tricon Global Restaurants changed names to YUM! Brands. However, it appears that instead of filing an amendment to change Tricon Global Restaurants to their new name of YUM! Brands, a new ID was created for YUM! Brands incorrectly listing them as a new and separate registrant. This error was just brought to our attention and therefore in order to rectify the situation, we are submitting a termination for registrant, Tricon Global Restaurants (ID: 44812-1038) dated June 30th, 2000.
