

Dear Mr. Krause:

This will confirm our understanding concerning this firm serving as Legislative Counsel to Community Service Society of New York commencing on July 01, 2002 until June 30, 2003.

The fee for these services will be \$100,000.00 (One Hundred Thousand Dollars) per year plus disbursements. This fee shall be paid in twelve equal installments of \$8,333.33. The first payment is returned with the copies of the signed retainer. Expenses will be billed as incurred and will include the photocopying, long-distance telephone calls, messenger service, travel, and other related disbursements.

New York State services included within the scope of this Retainer are set forth on page two. Representation on the city and federal levels include strategizing on specific projects selected by Community Service Society of New York, in consultation with WEMED.

New York City's lobbying law requires that we (1) register with the City Clerk and (2) file regular financial reports. The client is also required to file an annual financial report with the New York City on January 15<sup>th</sup> of each year. Furthermore, The New York State Lobbying Act (Chapter 2 of Laws of 2001) requires that we (1) register with the Lobbying Commission and (2) file regular financial reports. Additionally, as a client retaining a lobbyist, you will be required to file semi-annual reports with the New York Temporary State Commission on Lobbying each July 15<sup>th</sup> and January 15<sup>th</sup>. The Federal Regulatory Lobbying Act requires that we file regular financial reports on February 15<sup>th</sup> and August 15<sup>th</sup> of a Retainer Term. Clients do not have to file any reports on the federal level.

Please note that we must have a signed copy of your retainer before we can lobby on your behalf.

If the terms of this retainer are acceptable, please sign four (4) copies; keep one for your files and return three (3) to us, one of which will be filed with the New York Temporary State Commission on Lobbying and one with the Office of the New York City Clerk.
