In summary, the relationship with one client was terminated in 2003 and was so reflected in the mid-year report for that year. Regarding the other client, there was a name change involved and your office was appropriately notified with an amended filing in mid-year 2002. Specifically:

- o As part of the mid-year report for 2003 for L-3 Detection Systems, I reflected that it was a termination filing.


