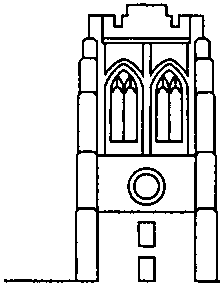

I am filing my Lobbying Report in written form rather than electronically because I am not able to complete the form correctly via electronic form LD-2DS. I called your help line on a few occasions, left my name and telephone number, and never heard back. I should add that I have an ACES certificate to file digitally.
