HR 1358 -- Energy Efficient Affordable Home Act of 1999, provisions dealing with tax credits for making energy efficient improvements.

HR 199 -- Children's Environmental Protection Act -- provisions dealing with environmental pollution.

HR 1657 -- A bill to disclose environmental risks to children's health and expand the public's right to know about toxic chemical use and release -- provisions dealing with toxic chemicals.

HR 1790 -- Chemical Safety Information and Site Security Act of 1999 -- provisions dealing with the public disclosure of accidental release scenario information in risk management plans.

S 1155 -- National Uniformity for Food Act of 1999 -- provisions dealing with amending the Federal Food, Drug and Cosmetic Act to provide for uniform food safety warning notification requirements.

S 1233 -- An original bill making appropriations for Agriculture, Rural Development, Food and Drug Administration, and Related Agencies programs for the fiscal year ending September 30, 2000.

HR 1906 -- FY 2000 Agriculture Appropriations Bill -- provisions dealing with making appropriations for Agriculture, rural development, Food and Drug Administration and Related Agencies for the fiscal year ending September 30, 2000.

S.J. Res. 27 -- A joint resolution disapproving the extension of nondiscriminatory treatment (normal trade relations treatment) to the products of the People's Republic of China.

S 743 -- A bill to require prior congressional approval before the United States supports the admission of the People's Republic of China into the World Trade Organization, and to provide for the withdrawal of the United States from the World Trade Organization if China is accepted into the WTO without the support of the United States.

S 1065 -- Chile Fast Track Act of 1999 -- Provisions dealing with negotiation for the accession of Chile to the North American Free Trade Agreement.

S. 1073 -- A bill to amend the Trade Act of 1974 to ensure that United States industry is consulted with respect to all aspects of the WTO dispute settlement process.

S 1636 -- HOPE for Africa Act of 1999 -- provisions dealing with new trade investment.

HJ Res. 57 -- China Trade Resolution -- provisions dealing with disapproving the extension of nondiscriminatory treatment to the products of the People's Republic of China.

H Res. 96 -- A resolution amending the Rules of the House of Representatives to require a two-thirds vote on any bill or joint resolution that either authorizes the President to enter into a trade agreement that is implemented pursuant to fast-track procedures or that implements a trade agreement.

HR 434 -- Sub-Saharan Africa Free Trade Bill -- Provisions dealing with a new trade and investment policy.

HR 884 -- A bill to require prior congressional approval before the United States supports the admission of the People's Republic of China into the World Trade Organization, and to provide for the withdrawal of the United States from the World Trade Organization if China is accepted into the WTO without the support of the United States.

HR 1942 -- A bill to encourage the establishment of free trade areas between the United States and certain Pacific Rim countries.
