To Whom It May Concern:


I am writing in an attempt to explain the current status of Mock & McSwain Consulting, LLC, its relationship with MAGTUBE and the to-date failure to register and/or update the company's lobbying disclosure status.

As indicated on the original lobbying registrations, Mr. Raymond Mock was registered as the sole contact and lobbyist for MAGTUBE at Mock & McSwain Consulting since that business relationship began in June of 2002. While continuing to represent some clients (including MAGTUBE) for the duration of that calendar year, Mr. Patrick McSwain and I ended our business relationship at Mock & McSwain Consulting several months later.

At the time I registered as contact for MAGTUBE, I listed a more current address 4503A Sahalee Court, Alexandria, VA 22312 for communication concerning this client. I can only surmise that since Mock & McSwain at that time represented multiple clients and probably listed multiple addresses as principal places of business, that somehow notice to the 4503A Sahalee Court address was not received.

That is no excuse however for failure to file the correct termination notice. I did indeed forget to file that notice when the relationship with Magtube ended in November 2002. Mr. McSwain is in no way responsible for that failure.
