The company also lobbied on program access issues addressed in both the draft legislation of the House Commerce Committee and Senate legislation on telecom reform (see S. 1504). On the net neutrality, EchoStar spoke on the issue as it related to the House Commerce draft telecom bill. Lastly, EchoStar raised awareness of the bundling practices of large programmers as the Senate Commerce Committee consider indecency legislation.
