A bill to reauthorize the grant program for reentry of offenders into the community in the Omnibus Crime Control and Safe Streets Act of 1968, to improve reentry planning and implementation, and for other purposes. Also pushed the need for legislation to reduce the sentencing disparity between powder and crack cocaine violations. Three bills have now been introduced in the Senate: S 1383, S 1685, S 1711.
