After consultations with your staff, we are submitting this letter, for the record, to amend reports previously filed by Quinn Gillespie & Associates ("QGA"), which is registered under the Lobbying Disclosure Act for the client noted above.

We recently discovered that certain lobbying reports submitted in the past by QGA do not, in every instance, identify the former covered official positions of some QGA employees who served as lobbyists. Below, please find a detailed accounting of these individuals, their former covered positions, and the reports on which their former covered positions should have appeared.
