Federal Bills - 106th Congress

H.R. 35, A bill to prohibit the possession or transfer of junk guns, also known as Saturday Night Specials.

H.R. 59, A bill to provide that the firearms prohibitions applicable by reason of a domestic violence misdemeanor conviction do not apply if the conviction occurred before the prohibitions became law.

H.R. 85, A bill to amend federal law to prohibit, with certain exceptions, the transfer of a handgun to, or the possession of a handgun by an individual who has not yet attained 21 years of age.

H.R. 87, A bill to prohibit Internet and mail order sales of ammunition by anyone except a licensed firearms dealer, and to require dealers to record all sales of 1,000 rounds of ammunition to a single person.

H.R. 109, A bill to better regulate the transfer of firearms at gun shows.

H.R. 218, A bill to exempt qualified current and former law enforcement officers from state laws prohibiting the carrying of concealed handguns.

H.R. 315, A bill to make it unlawful for anyone but licensed dealers to purchase more than one handgun during any 30-day period.

H.R. 347, Citizens' Self Defense Act of 1999.

H.R. 407, The Second Amendment Restoration Act of 1999.

H.R. 492, Right to Safety and Personal Protection Act.

H.R. 515, A bill to make it illegal for a manufacturer or importer to sell, transfer or deliver a handgun without a discharge protection product that would prevent children from operating the handgun.

H.R. 724, Gun Buy Back Partnership Act of 1999.

H.R. 3057, A bill to amend title 18, United States Code, to prohibit gunrunning, and provide mandatory minimum penalties for crimes related to gunrunning.

H.R. 3255, A bill to assist local governments in gun buyback programs.

H.R. 3279, A bill to prohibit the possession of a firearm in a hospital zone.

H.R. 3444, A bill to repeal section 658 Of Public Law 104-208, commonly referred to as the Lautenberg amendment.

H.R. 3563, A bill to prevent the theft of firearms from commercial carriers.

H.R. 3597, A bill to amend title 18, U.S. Code, to increase the penalties for possessing or using a firearm in the commission of a felony crime of violence or drug trafficking crime, and to require juveniles age 14 or older who so possess or use a firearm to be tried as adults.

H.R. 4000, A bill to amend chapter 44 of title 18, U.S. Code, to require ballistics testing of all firearms manufactured and all firearms in custody of federal agencies, and to add ballistics testing to existing firearms enforcement strategies.

H.R. 4009, A bill to ban the import of large capacity ammunition feeding devices, to promote the safe storage and use of handguns by consumers, and to extend Brady background checks to gun shows.

H.R. 4066, A bill to enhance the enforcement of gun violence laws.

H.R. 4220, A bill to amend title 18, U.S. Code, to add certain firearms related crimes to the list of crimes giving rise to a presumption of dangerousness for purposes of hearings on the release of defendants before trial.
