As a Master Science in Electr. Eng., Registered Lobbyist to the U.S. Congress and REGISTERED CANDIDATE TO THE U.S. HOUSE OF REPRESENT FROM 12 CONGRESSIONAL DISTRICT OF OHIO, I became victim of three times false arrests on Jan. 07, 23, and 27, 2000, was four times falsely charged with prejustice at time of false arrests. I was unlawfully deprived my liberty and freedom by 33 days (27 Jan. to 29 Feb. 2000) under false arrest. I was sent to Mental Hospital on 29 Feb. and release on 03 May, 2000. All four false cases were dismissed by the Court but I did not get mandatory remedies or compensations. I did not get opportunity to vote in primary election on March 07, 2000 in Franklin County, OH. I am sure that became a political slaver or prisoner of conscience. I did not have taken my rights to vote by the Court. The United States is not the Soviet Union and shall stop this unconstitutional practice against own citizens and stop hate crimes.
