



Dear Mr. Johnson:

This will confirm our understanding concerning this firm serving as Legislative Cou to Alice Hyde Medical Center on the Federal level commencing on January 1, 2004 to December 31, 2004. The representation will be on specific issues identified jointly by A Hyde Medical Center and Wilson, Elser, Moskowitz, Edelman & Dicker LLP.






