This letter is in response to a notification dated October 4, 2000 from the Clerk of the House of Representatives (attached) regarding the status of the semi-annual lobbying report of the Glass Packaging Institute (GPI) - Senate ID # 16271 - for activity during the first half of this year.

As in-house lobbyist for the Glass Packaging Institute, I engaged in no lobbying activities on the Institute's behalf during the period January 1 to June 30, 2000. Due to a misinterpretation of the rules governing reporting requirements for time periods during which no actual lobbying takes place, our staff neglected to submit the required Lobbying Report for this time period. At this time we are submitting the required Lobbying Report.

In addition, on June 30, 2000 the Glass Packaging Institute terminated the use of an in-house lobbyist. The attached Lobbying Report reflects this action and thus also serves as a termination of the GPI's lobbying registration.

A similar letter and report has been submitted to the Clerk of the House of Representatives.
