S. 706 and H.R. 1436 - Nurse Reinvestment Act - Reestablishes a national nursing service corps, expands Medicare and Medicaid funding for clinical nursing education and to reimburse some home health agencies, hospices and homes for nurse training.

S.572 and H.R. 854 - Medicaid Safety Net Hospital Preservation Act of 2001 - Extends to 2003 and beyond Medicaid disproportionate share (DSH) payments included in last year's Balanced Budget Act relief legislation

S.424 and H.R. 1669 - Earthquake Loss Reduction Act of 2001 - Provides incentives to encourage private sector efforts to reduce earthquake losses; establishes a national disaster mitigation program.
