Please find the enclosed lobbying reports submitted for The Palmer Group.


As noted in your most recent letter, the 2001 Year End reports are delinquent. It is because of my oversight and misunderstanding of the requirements that each of the reports were not filed. As you will see, of the 5 required reports, 3 are "no activity" reports. In addition to the 2001 Year End reports, I am also enclosing 2002, and termination reports for each of my 5 former clients.

Effective the end of 2002, The Palmer Group no longer represents clients before the Congress/Senate. While The Palmer Group is still a business, my only contract is with the Louisiana Municipal Advisory and Technical Assistance (LaMATS) Bureau in Bayou Rouge, LA to perform database management and administrative processes associated with their municipal insurance premium tax collection program. None of these activities involve lobbying at any level of government.

I deeply regret the filings are so delinquent, and hope this has not caused your office any difficulties. I am aware that the Notice of Noncompliance sent to me was sent via certified mail, so I am prepared to reimburse your office for this, and any other administrative expense. 
