FY2008 Budget - Provide additional funding for agriculture spending in the FY08 budget resolution: Payment limits - amendment by Senator Grassley and Senator Dorgan. It will limit farm payments to \$250,000 per person per year and apply the approximate \$100 million per year saving (\$1 billion over 10 years) to conservation, nutrition, renewable energy and rural development. Food and Agriculture Risk Management for the 21st Century Act (FARM 21). The bill primarily focused on transitioning the current farm subsidy of risk management accounts, while increasing funding for conservation and nutrition programs. Emergency war supplemental funding bill. The spending measure includes the agricultural disaster assistance provision, extension of the MILC program and 2007 peanut storage and handling funding.

Senate Immigration Bill (from previous page) Numerous Amendments: Vitter amendment would strike Title VI. Title VI established the Z-A visa that would provide legal status to agricultural workers and permit the opportunity to apply for permanent residents status. Allard amendment (S.A. 1189) would strike language which provides an extra 50 points for Z-visa holders seeking permanent resident status, including 25 points if the holder works in agriculture for 3-5 more years. Comyn amendment (S.A. 1184) would expand the types of crimes that would permanently bar undocumented immigrants from obtaining legal status. Menendez amendment (S.A. 1194) would move the cut off date for those currently awaiting green cards from Jan. 1, 2005 to Jan. 1, 2007. Dodd amendment (S.A. 1199) would more than double the number of green cards available under the bill for the parents of citizens. Clinton, Hagel amendment (S.A. 1183) would eliminate a numerical cap on the visas available to the spouses and minor children of U.S. permanent legal residents. Obama amendment (S.A. 1202) would sunset the point system after five years. Dorgan amendment (S.A. 1267) would eliminate the requirement that Y-1 visa holders must leave the U.S. before they are able to renew their visas. Senate Immigration Bill (see next page addendum)

Death Tax Bill. Representative Hulshop's bill will repeal the sunset clause in the law so that when death tax repeal takes place in 2010, it will be permanent. IRS Notice 2006-108; Conservation Reserve Program (CRP) Payments will be subject to Self-Employment taxes. H.R. 1023. Repeals the 3% withholding requirement passed last year (a part of the Tax Increase Prevention and Reconciliation Act of 2005).

S. 1150 interstate shipment of state inspected meat. Would eliminate the prohibition on interstate shipment of state inspected meat and poultry. H.R. 1495 Water Resources Development Act of 2007 (WRDA). The bill would authorize the U.S. Corps of Engineers to construct new 1,200 foot locks on the Upper Mississippi and Illinois River.
