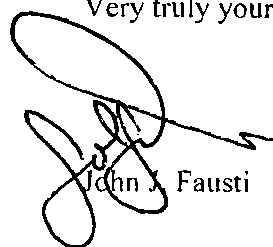
Please note that this letter and the attached reports supercede what we erroneously submitte

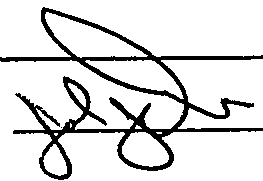
