It has been brought to our attention that errors were made in the Lobbying Reports filed for Safari Club International for the years 1999, 2000 and 2001. During those years we had a contract lobbyist and in-house lobbyists. In filing the organizational reports, we failed to state the total amount paid for both contract and in-house lobbying.

Attached please find the corrected sheets for those three years. All other information on the original filings was correct, and the total amount spent for lobbying was also correct in the original filings. When added to the amount reported by the contract lobbyist, the figures were accurate. The error was in not combining the two amounts on the organization's report.
