This funding is critical to the work that Johns Hopkins is doing in several at risk schools; The Center for the Social Organization of Schools also has developed several successful models such as Success for All and the National Network of Partnership Schools using grant funds from DDE; advocated for an FY2003 funding level for NEH at \$150 million. This would be a \$25 million or 20 percent increase over the FY 2002 level of \$125 million.
