ATTACHMENT A

Cruden Investments Pty. (incorporated in the State of Victoria) has a voting interest in approximately 30% of the News Corporation Limited ("News Corp."). News Corp., which is incorporated under the laws of the State of South Australia, indirectly owns all of the stock of the following entities, each of which is incorporated in Delaware and which, together with their respective wholly-owned U.S. subsidiaries, conducts operations or business in the United States:

American Sky Broadcasting, LLC*
Twentieth Century Fox Film Corporation
News America Publications, Inc.
Harper Collins Publishing, Inc.

In addition, News Corp. indirectly owns all the stock of News America Incorporated, a Delaware corporation, which owns the common stock (which constitutes 24% of the voting stock) of Twentieth Holdings Corp., a Delaware corporation which owns all of the stock of Fox Television Stations Inc., Fox Broadcasting Company and FXM Networks, Inc.

*Fox Television Stations Inc. holds a 99% interest and Twentieth Holdings Corp. holds a 1% interest in American Sky Broadcasting, a Delaware limited liability corporation.
