Attached is a completed Form LD-2 for the above-referenced client covering the two-week period June 16 through June 30, 2003. Thank you for bringing this oversight to our attention by your First Notice of Non-Receipt dated February 18, 2004.

In reviewing our records, the original registration was given an effective date on Line June 16, 2003. It was filed and date stamped by your office just above Line 1 with the date of July 31, 2003. Due to our oversight, we reported on Form LD-2 beginning July 1, but should have also reported for the first half of the year so as to begin two weeks earlier. Our records indicate that our second lobbying contact occurred at a time such that we, in fact, could have correctly registered after July 1, making the 2003 first half report unnecessary. Nevertheless should have been filed, given the effective date we wrote on the Form LD-1, and we do regrethis error.
