Dear Mr. Johnson:

This will confirm our understanding concerning this firm serving as Legislative Counsel to Alice Hyde Medical Center on the Federal level commencing on January 1, 2004 until December 31, 2004. The representation will be on specific issues identified jointly by Alice Hyde Medical Center and Wilson, Elser, Moskowitz, Edelman & Dicker LLP.

The fee for these services will be \$50,000.00 (Fifty Thousand Dollars) per year plus expenses. This fee shall be paid in four equal installments of \$12,500.00. The first payment is to be returned with the signed retainer. The remaining payments will be due on April 1, 2004, July 1, 2004 and October 1, 2004. Expenses will be billed as incurred.

The Federal Regulation of Lobbying Act requires that 1) we file this retainer with initial registration, and 2) we file financial reports on February 15, 2004, August 15, 2004 and February 15, 2005. Clients do **not** have to file any reports on the federal level.

Please note, we must have a signed retainer before we can lobby on your behalf. If the terms of this retainer are acceptable, please sign both originals; keep one for your files and return one to us.


