H.R. 2992

A bill to amend the Indian Gaming Regulatory Act to protect Indian tribes from coerced labor agreements.

S.399/H.R.1811

S.611/H.R.361

A bill to establish the Commission on Indian Recognition in the Department of the Interior.

S.985

A bill to provide for negotiations between states and tribes that wish to operate gaming enterprises.

S.2920

A bill to amend the Indian Gaming Regulatory Act to create an Indian Gaming Trust Fund and to clarify federal regulation of Indian gaming.

H.R. 4556

A bill to treat Indian tribal governments the same as state and local governments or nonprofit organizations for unemployment compensation programs.

H.R. 4578

A bill making appropriations for the Department of the Interior and related agencies for the fiscal year ending September 30, 2001 and for other purposes.

S. 692

A bill to prohibit Internet gambling.

H.R. 3125

A bill to prohibit Internet gambling, and for other purposes.

H.R. 5020

A bill to prohibit Internet gambling.
