To Whom It May Concern:

As required under Section 5 of the Act (2 U.S.C. §1604), Teleglobe USA Inc., and Tel Communications Corporation (collectively "Teleglobe") submits its Year End LD-2 report period January 1, 2002 through December 31, 2002 and January 1, 2003 through June 30, 2003. Please also be advised that on May 28, 2002, Teleglobe USA Inc, Teleglobe Communications Corporation and a number of its affiliates, filed for bankruptcy protection in the US Bankruptcy Court of District of Delaware, Case No. 02-11518. Please also note that on December 31, 2002, after obtaining court approval, BCE Inc. and its affiliates sold all of their common and preferred shares in Teleglobe Inc. to 6038441 Canada Inc. an affiliate of Ernst & Young Inc. the appointed monitor in Canada. On September 18, 2002 Teleglobe announced that an affiliate Cerberus Capital Management, L.P. and TenX Capital Partners, LLC has agreed to purchase the forward-going Teleglobe business, which included the assets constituting the Core Business in Canada, USA, UK etc. The purchase agreement (the "Purchase Agreement") was approved by the Ontario Superior Court of Justice on October 2, 2002 and the US Bankruptcy Court of District of Delaware on October 11, 2002. The transaction included the purchase of Teleglobe names and all related trademarks. On December 9, 2002, Teleglobe Inc. announced that it has finalized an Interim Management Agreement for its core voice and data business with Acquisition LLC, an affiliate of Cerberus Capital Management L.P. and TenX Capital Partners, LLC. Under terms of the agreement, TLGB assumed day-to-day management responsibility for the operations and financial performance of the business effective December 1, 2002. On June 30, 2003, the transaction contemplated by the September 18, 2002 Purchase Agreement was completed and Teleglobe has changed its name to Teleglobe America Inc.
