Pursuant to my conversation with your office today, attached please find the amended filing for L. Londell McMillan, PC (now known as "The McMillan Firm") indicating th representation of the former client, Artist Empowerment Coalition, was concluded on December 31, 2003. The firm did not represent this organization in a lobbying capacity after this date, nor were there any fees or expenditures to report for subsequent filing periods. Please amend the register and record for L. Londell McMillan, PC to reflect same.

As explained, L.
