As Exhibit 2 makes clear, a 2003 year-end termination LDA report for the ICI (with the Senate ID Number 33762-12) was timely filed with the Secretary of the Senate and Clerk of the House. As Exhibit 2 reveals, the Clerk of the House processed the LDA reporting form. The confusion with your office may be that the 2003 year-end report for the ICI lists McGuire Woods as the name of the registrant (with Scott Hodes as the contact) while the previous registration listed Ross & Hardies (with Scott Hodes as the contact). Mr. Hodes left Ross & Hardies and joined

When Mr. Hodes subsequently left McGuire Woods and joined Bryan Cave LLP, the LDA registration for the ICI was similarly changed to Bryan Cave.
