Dear Mr. Krasnauskas:

This will confirm our understanding concerning this firm serving as Legislative Coto Canton-Potsdam Hospital on the Federal level commencing on January 1, 2004 December 31, 2004. The representation will be on specific issues identified jointly by Cato Postdam Hospital and Wilson, Elser, Moskowitz, Edelman & Dicker LLP.
