**HR 3779 To amend the Servicemembers Civil Relief Act to prevent the disruption of the education of children who change residence based on the military service of their parents.**

**HR 4180 To amend title 10, United States Code, to provide reimbursement for members of the Armed Forces retired for a combat-related disability for travel to military treatment facilities for medical care during the first two years after such retirement.**
