

You are required by law to provide an appropriate response within **60 days** of the date of the letter [2 U.S.C. § 1605(8)]. Failure to do so will result in referral of this matter to the United State Attorney for the District of Columbia for legal action. Please be advised that violators of the Lol Disclosure Act are subject to a civil fine of up to \$50,000.
