Dear Mr. Krause:

This will confirm our understanding concerning this firm (WEMED) acting as Legislative Counsel to the Community Service Society of New York (CSS) commencing on July 1, 2005 until June 30, 2006. New State and New York City services included within the scope of this retainer are set forth on page 2. Representation on the Federal level will include strategizing on specific projects selected by CSS in consultation with WEMED.

The fee for these services will be \$70,000.00 (Seventy Thousand Dollars) per year ^{including} plus expenses. This fee shall be paid in twelve equal monthly installments of \$5,833.33. The first payment is to be returned with the signed retainer. Travel expenses will be billed as incurred.

In accordance with the New York State Lobbying Act and the New York City lobby law, we are required to register with both the New York Temporary State Commission on Lobbying and the Office of the New York City Clerk. As a client retaining a lobbyist, you will be required to file Semi-Annual Reports with the New York Temporary State Commission on Lobbying on January 15, 2006 and July 15, 2006. Furthermore, you will be required to file Annual Financial Reports with the New York City Clerk's Office on January 15, 2006 and January 15, 2007. The Federal Regulation of Lobbying Act requires that WEMED file Bi-Annual Financial Reports on February 15, 2006 and August 15, 2006, however, clients are not required to file reports on the Federal level.

Please note that we must have a signed retainer before we can lobby on your behalf.

If the terms of this retainer are acceptable, please sign where indicated and return the original to the undersigned. A copy will be filed with the New York Temporary State Commission on Lobbying, the Office of the New York City Clerk, the United States Senate Secretary and the House of Representatives Clerk.


