We are in receipt of the email communication from the Senate Office of Public Records sent April 2, 2008, asking us to review lobbyist information for each client and to make any corrections when we file the first 2008 quarterly reports due April 21, 2008. I am sending you this letter at the suggestion of Dana McCollum regarding several situations, described below, that cannot be corrected in this manner.

We have reviewed the "active" list of lobbyists contained in the April 2, 2008 report and find that five of the lobbyists on the list have departed Vinson & Elkins LLP. We have terminated registrations for the clients under which these individuals were listed as a lobbyist several years ago. Those individuals who are no longer "active" and no longer with Vinson & Elkins are listed below:

The remaining individual, Joe Bill Watkins, remains with Vinson & Elkins LLP under which he was listed as a lobbyist, Kansas City Southern Inc. His registration was terminated as of December 31, 2001, in our Report filed February 14, 2002.

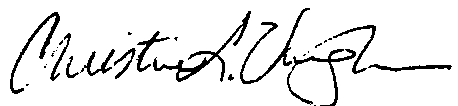

This firm has never employed at "Christine Graves." The name included in the email may be a combination of Christine Vaughn and Caroline Graves. That may explain why Caroline Graves under "Active Lobbyists" when she should be on the "Terminated Lobbyist" list.
