

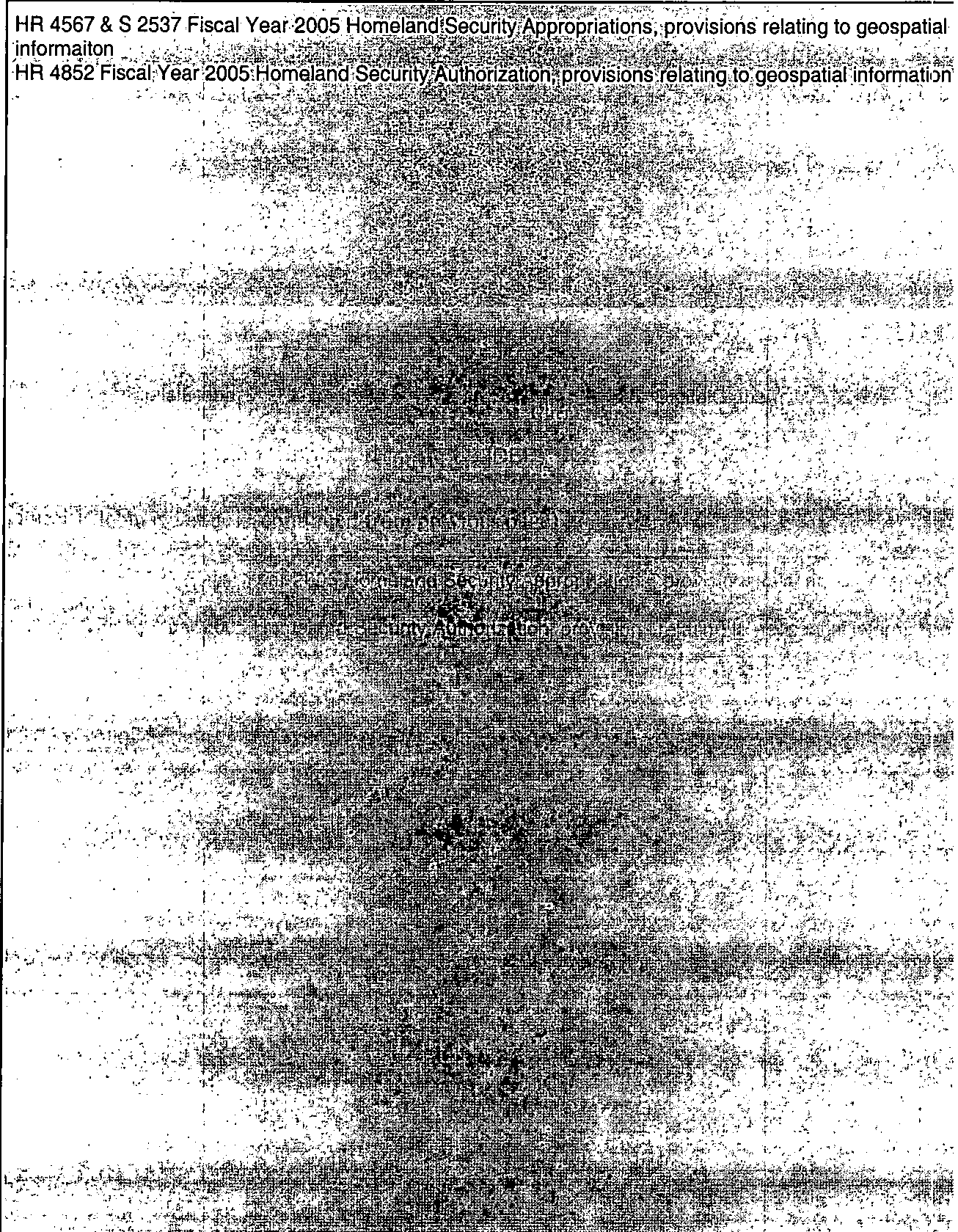

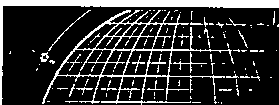

Dear Secretary,

This letter is in response to a "First Notice of Non-Receipt" notice we received from the Office of the Clerk of the House of Representatives dated January 26, 2007 citing a missing lobbying report for the period July 1, 2005 to December 31, 2005.

DigitalGlobe did electronically submit a lobbying form by the February 14, 2006 due date, however an error was made on Line #8 of the form indicating that it covered the reporting period Year End 2006 (instead of 2005). Please see the attached copy of the form submitted on February 14, 2006 which shows the error as well as the submission confirmation from the House and delivery note to the Senate. Attached is an amended form for the reporting period Year End 2005 with the correction on Line #8 indicating the proper year.

Additionally, the House notice prompted an internal review of all past lobbying forms filed by DigitalGlobe. As a result, it was discovered that an error was made on Line #13 for each of the filing periods Year End 2003 through Year End 2005. This is a result of a misunderstanding of what constitutes as "Expenses related to lobbying activities". Attached are amended forms covering the periods Year End 2003 through Year End 2005 correcting the amount on Line #13 for each.

DigitalGlobe takes compliance with Federal lobbying very seriously. As a result of the House notice, we have undertaken a review of our processes and procedures to see if there are areas for improvement and to ensure continued full compliance with the ever-changing lobbying environment.
