To Whom It May Concern:

I am writing in response to a letter from the Office of the Clerk for the U.S. House of Representatives, dated December 27, 2006, regarding this firm's registration.

Attached please find a copy of the LD-2 we filed February 14, 2005, along with our verification of filing form from the Secretary of the Senate's Office of Public Records. This was intended to be a 2004 Year-End and Termination report.

It appears that either because of minor clerical errors or a computer glitch, it was not accepted for filing by the House. There appears to be a discrepancy regarding the termination date on Line 10 between our copy of the filing and the electronic version available online from the Secretary of the Senate's Office of Public Records website, sopr.senate.gov. The original filing has the Termination date as 12/31/2004; however, the electronic version has the date Dec 30, 1899 listed on Line 10.

We have been advised by both House and Senate offices that, under the circumstances, we should file replacement LD-2s to ensure that both offices have the same data. Please note that both offices have moved since the original filing and the new address is reflected on the form. Also because the partner who signed the original filing is no longer with our firm, this form is being submitted under my name.
