
Sir or Madam:

This letter accompanies several lobbying reports covering January 1 - June 30, 1999 filed by Collier, Shannon, Rill & Scott, PLLC. Please note that Mr. Scott Sinder joined the firm as a member in mid-June 1999 and consequently the firm registered the following clients under the Lobbying Disclosure Act: (1) American Land Title Association; (2) National Association of Professional Insurance Agents, Inc.; (3) National Association of Life Underwriters; (4) Independent Insurance Agents of America, Inc.; and, (5) Council of Insurance Agents and Brokers.

Mr. Sinder joined Collier, Shannon after working with two other law firms during the first six months of 1999: Jenner and Block; and, Baker and Hostettler. Collier, Shannon is reporting no lobbying activity for these five clients for the first six months of 1999. However, Mr. Sinder would like your offices' records to reflect that he billed approximately \$10,000 to the American Land Title Association and approximately \$30,000 to each of the other four clients for lobbying activities when working with these other law firms between January 1 and June 15, 1999.
