

I am writing to inform you that I, Jeffrey A. Lane, was incorrectly listed in the lobb registration filed on January 2, 2004 by my firm, Womble Carlyle Sandridge & Rice, lobbyist for the Specialty Tobacco Council. The effective date of the registration was September 24, 2003.

I have not lobbied and do not plan to lobby on behalf of the Specialty Tobacco Council, and my firm made that clear by correcting its original filing error in an amended lobbying registration form filed on February 3, 2004. 




