


Once again I have encountered difficulty in attempting to comply with the Lobby Disclosure Act and file electronically.

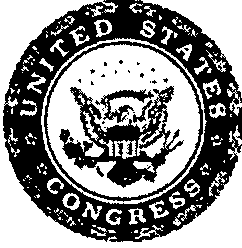
