





Dear Mr. Sisto:

This will confirm our understanding concerning this firm serving as Legislative Counsel to Healthcare Association of New York State on the Federal level commencing on January 1, 2003 until December 31, 2003. The representation will be on specific issues identified jointly by Healthcare Association of New York State and Wilson, Elser, Moskowitz, Edelman & Dicker LLP.


The Federal Regulation of Lobbying Act requires that we file regular financial reports on February 15th and August 15th. Clients do not have to file any reports on the federal level.
