A bill to amend the Indian Gaming Regulatory Act, and for other purposes.

H. R. 103

A bill to amend the Indian Gaming Regulatory Act to protect Indian tribes from coerced labor agreements.

H. R. 556

A bill to prevent the use of certain bank instruments for unlawful Internet gambling, and for other purposes.

H. R. 2244

A bill to amend the Indian Gaming Regulatory Act to require State legislature approval of new gaming facilities, to provide for minimum requirements for Federal regulation of Indian gaming, to set up a commission to report to Congress on current living and health standards in Indian country and for other purposes.
