To whom it may concern:

Please accept for filing registration and reporting materials submitted by McLarty Internatic LLC, dba Kissinger McLarty Associates, in connection with advisory work performed on behalf of four corporate clients based or incorporated outside the United States.

Although registrant engaged in no lobbying contacts on behalf of these four clients, after reconsultation with counsel registrant has now concluded that certain strategic advice it offered these companies requires registration under the FARA, which as you know permits registration for private clients under the Lobbying Disclosure Act.

The four corporate clients are: Telefonos de Mexico (Telmex), Philippine Long Distance Company (PLDT), Global Crossing, Ltd., and Areva, Inc. The filings relate to work performed for Telmex in 2000-02, for Global Crossing in 2002-03, for PLDT in 2003-04, and for Areva in 2005. Registrant was not aware until the recent discussions with counsel that its advice to the four corporate clients required registration, and its failure to file earlier was entirely inadvertent and is now being corrected. No employees or affiliates of registrant engaged in any lobbying contact with US officials in connection with this work.

Registrant is a separate entity from Kissinger Associates, Inc. (KAI), a firm with which it entered into a strategic alliance and revenue-sharing arrangement. Kissinger Associates as well as registrant have adopted long-standing policies against activities requiring registration under the FARA/LDA. Neither Henry Kissinger nor any other employee of Kissinger Associates participated in the activities to which the registration occurs, and Kissinger Associates, Inc. is not a party to the registration.

The activities for which registration is being made have ended, and termination notices are hereby being filed for each of the four clients. Registrant will adhere to its policy against such activities in the future.


