Visited offices of all ten members of the Maryland Delegation. Worked toward increased access to higher education for low-income students by strengthening support for grants and early intervention programs, particularly the Pell Grant program; increase in financial aid support for graduate education through GAANN, Javits and FLAS fellowship and grant programs; increased access to both undergraduate and graduate education by raising student loan borrowing limits.
