

EXECUTIVE SUMMARY

Cardinal Health System, Inc. (Ball Memorial Hospital) is unable to mee reclassification criteria to be reclassified to the Indianapolis MSA for wage in purposes simply because it is the only hospital in the Muncie MSA. The Cent for Medicare and Medicaid Services have established by regulation a mandate reclassification criteria that makes it impossible for a hospital that is the only hospital in a Metropolitan Statistical Area (MSA) to seek an individual hospit wage index reclassification to another nearby MSA.

Cardinal Health System, Inc. seeks:

1. A legislative reclassification for any Delaware County, Indiana hospital to be reclassified to Indianapolis (permanently or for per three years).

OR

2. Congress or the Administration to change the criteria to exempt a hospital MSA from the 108% criteria.
