Thank you for your notice of November 27, 2001, regarding the non-receipt of lobbying report for VT Systems, Inc., for the period January 1, 2001, through June 30, 2001. VT Systems submitted its report on December 26, 2001, indicating that there was no reportable lobbying activity on behalf of the company during that period.

This memorandum supplements the December 26<sup>th</sup> submission in order to provide an explanation for the delinquency in filing. VT Systems did not engage in any lobbying activity during the relevant period, and there was an oversight in transferring duties between employees due to changes arising from the shifting of company operations during the period. 
