I am in receipt of a letter from your office dated September 1, 2006, re: FIREARMS TRAINING SYSTEMS (14600-12). The letter was addressed to John A. Morelli, a former CFO of FATS, Inc.

FATS Inc. has never lobbied, nor do we currently perform any lobbyist activities. We do engage a registered lobbying firm. For reasons unknown to anyone here, Mr. Morelli erroneously registered Firearms Training Systems, himself and me as lobbyists sometime in the 2003-2004 timeframe. I was made aware of this mistake on or about the first of this year. I filed a Form LD-2 with the appropriate House and Senate agencies on 5 January 2006. I indicated on line 10 of the form that I was submitting a Termination Report with an effective date of 1 January 2004. I have enclosed a copy of the form for your consideration and information.
