In calculating the expenses reporting on line 13 that are related to lobbying activities conducted by trade associations of which the registrant, Liberty Mutual is a member, we used that portion of dues reported to us by the associations as being non-deductible lobbying expenses. Because those figures do not distinguish between state and federal lobbying activities, and we believe most are in fact related to state lobbying, we have probably overstated the amount reported on line 13.
