Legislation of interest includes the Farm Security Act of 2001 (H.R. 2646), the Agriculture Conservation and Rural Enhancement Act of 2001 (S. 1731), the Farm Security and Rural Investment Act of 2002 (P.L. 107-171), and the Bipartisan Trade Promotion Authority Act of 2001 (H.R. 3005; P.L. 107-210).


