Enclosed please find the delayed filing of my second half 2000 Lobbying Report. Once again, accounting difficulties occasioned the delay. I apologize.

The report for Barr Laboratories is the sole enclosure. However, I must ask your advice regarding another entity. In January, I signed an agreement with a not for profit organization to undertake certain activities that would have been covered by provisions of the Lobbying Disclosure Act. Subsequently, it became apparent that I would not be able to obtain the results that we had anticipated. I have never billed nor have I received any payment from this organization. I informed them I would not be billing under the proposed contract.

I shy proposed contract because I never received a copy signed by an officer of the organization. I have no reason to believe that they ever signed a copy of that proposed contract. They have my assurance that I neither expect nor would I be willing to accept any payment.

My assumption is that no registration is required. If you have another view, please let me know and I will forward a Lobbying Registration to you on or after May 29 when I return to the city.
