Our firm no longer provides lobbying services to Micron Technology, Inc. (House ID No. 34034005 / Senate ID No. 1184575). Therefore, I submitted a termination report to the House and the Senate on July 25th.

On August 16 the Secretary of the Senate notified me that the termination report was incomplete, because we did not complete line 12. I did not check the boxes on this line, because our firm did not receive any income from Micron Technology for lobbying services between the date of our initial registration and the date of the termination report. In the interests of full disclosure, I have prepared an amended termination report which confirms that our firm received less than \$10,000 from Micron Technology, Inc. during the last disclosure period.
