**MEMORANDUM**

The attached letter seeking submission of the LD-2 for ElectriCities of NC arrived by USPS today. This memorandum is in response.

I sent filings collectively for four clients to the Office of Public Records on February 14 via USPS in one mailing. I have attached a file copy of the filing of all of the LD-filings for year-end 2004 in case your office received none of them. Flagged for reference specifically is the ElectriCities of NC, which you have already deemed to be missing.

Additionally, I have included the termination report for McMillan, Talley and Associates for ElectriCities of NC filed on 12/31/01 and the lobby registration for Robert Talley Talley & Associates submitted shortly thereafter to reflect the termination of the company McMillan, Talley & Associates and the removal of Alex McMillan as a lobbyist registered on behalf of ElectriCities of NC.

Since filing the termination report, I have filed as Robert Talley, Talley & Associates. At the time of filing the 2002 midyear report I was orally advised by the Office of Public Records to use the same filing number for the client as previously issued. I have continued to do this per the instructions provided. However, I continue to receive correspondence related to ElectriCities of NC addressed to McMillan Talley & Associates. I would respectfully request that your records be updated to reflect the changes submitted in 2001.

I have and continue to work to be in full compliance with the LDA of 1995 and stand ready to provide you with whatever additional information is necessary. Please contact me immediately at (202) 296-4114 should any additional information be necessary to fulfill my obligation to continue to be in compliance with the law.
